**Propositions:** Ben Commons reviewed the four (4) propositions proposed by & for the unit owners.

- Proposition 1- Vote on Rollover of Surplus Funds
- Proposition 2– Vote on 2021 Audit
- Proposition 3– Vote on Waiving Full Reserves

Owners comments regarding each proposition were heard and their questions were answered.

President Raymond Smith, then, called for the vote. Votes were collected. President Raymond Smith called for an intermission while votes were being counted by the Tellers. The meeting was resumed.

Ben Commons, Property Manager, then reported the results of the votes on the three propositions.

## Results of the Election Ballots

Congratulations to Doug Bender, Raymond Smith and Eric Young for retaining their seats on the Long Bayou Association Board

### **Owners Comments:**

Owners spoke about Annual Meeting Packets that were never received by residents and/or never received back by the office. Ben and Raymond Smith spoke about changing the date of our election to February, so more of our residents are present. A second idea was to enable online voting for our propositions and our Board Members. If residents are not online, they can opt out of online voting and receive a printed packet as they currently receive. A survey of residents present at tonight's meeting was taken and an overwhelming majority wanted online voting.

Ben Commons, our Property Manager, told the owners about the Surfside Task Force. The Surfside was the high rise condominium building in South Florida that collapsed and fell down. The Surfside Task Force resulted in the following Task Force Report.

The Florida Bar Condominium Law and Policy Life Safety Advisory Task Force Report includes a number of recommendations for condominium developments in Florida, including:

- •Require timely maintenance and repair
- •Empower condo boards to impose assessments on owners
- •Empower condo boards to borrow money to pay for repairs
- •Mandate engineer or architect reports on each building's common elements
- •Require those common-element reports to be updated every five years
- •Boost requirements for cash reserves

According to the Task Force Chair and Florida attorney, Bill Sklar, the recommendation to boost cash reserves is likely one of the most controversial proposals. Potentially new laws may go into affect over the next 3-5 years to increase reserve funds.

A motion for adjournment was made by Raymond Smith and seconded by Doug Bender. The motion passed unanimously, 4-0. The meeting was adjourned at 7:55 p.m.
