Long Bayou Condominium Association, Inc Membership Annual Meeting – November 18, 2014 Minutes

A meeting of the Members of the Long Bayou Condominium Association, Inc. was held November 18, 2014 at 7:00 p.m. in the auditorium of the Clubhouse located at 9777 62nd Terrace N, St. Petersburg, FL 33708, pursuant to the Notice properly posted.

It having been determined that a quorum of unit owners (158) were present or represented by proxy, Raymond Smith, President called the meeting to order at 7:23 p.m. and led the Pledge of Allegiance.

Quorum: was met with 158 in Person or Proxy.

Minutes: Reading of the previous year's annual board meeting minutes was waived; Craig Tatar made a motion to approve the previous November 19, 2013 board minutes. The motion

was seconded by Judy Kovatch. The motion passed unanimously.

President's Report: President Raymond Smith said:

- he thanked his Board of Directors for all of their hard work throughout the year. He commended them for working so well together;
- he commended and thanked Ben Commons for his continued hard work.
- he commended and thanked Craig Tatar for his continued hard work on our website, www.longbayoucondos.com, his work as secretary and for sharing his computer expertise for the past two years.
- Raymond Smith, Joe and Mark totally remodeled the Auditorium Womens' bathroom with a new vanity, paint, mirror, high toilets and stall dividers;
- the sidewalk behind Building 4 was put in complete with drainage at a cost of \$4,000.;
- we received quotes of \$3,000. and \$5,000. for power washing the pool area pavers, evening them out, sanding them and putting down a finishing sealer coat. Mark and Joe did the job for a cost of \$700 plus materials saving us a substantial amount of money.
- all of the laundry rooms in Buildings 1-9 are being renovated by Joe and Mark with new paint, new ceilings and waxing of floors;
- we should have a rollover going into next fiscal year of \$45,000-\$50,000.;
- the Rules Committee and/or the owners came up with all of the propositions to be voted on tonight. Myself (Raymond Smith) nor Ben had anything to do with any of the propositions except for the one regarding the background criminal record check after many owners expressed concerns.

<u>Propositions</u>: Ben Commons reviewed the seven (7) propositions proposed by the Rules Committee/Owners and reviewed by the attorney to be voted on by the unit owners. Ben, also, read over the choices available for each proposition to be voted upon. Owners comments regarding each proposition were heard and questions were answered. President Raymond Smith, then, called for the vote. Votes were collected. President Raymond Smith called for an intermission while votes were being counted by the Tellers. Coffee and donuts were served and enjoyed during the intermission. The meeting was resumed.
