Instructions for Verified Public Nuisance Affidavits

- The affidavit has 2 pages- Both sides must be completed prior to being notarized.
- Two or more, adult citizens from unrelated households must participate. The more neighbors involved, the stronger the case.
- Each person must fill out their own statement completely, and in their own handwriting. No one shall sign another person's name on a affidavit.
- All statements should begin, and end on the same date. Date and Times must be clear and well documented.
- After being notarized. All affidavits should be gathered from participating neighbors, mailed and/or delivered to Animal Services together.
- Once verified affidavits are turned in to Animal Services and being processed- if violations are observed, please call in complaints.
- Animal Services shall educate, and contact the animal owner prior to any enforcement activity. Citations will be issued at the discretion of the department.
- Participating citizens (witnesses) may be called into court to testify if a defendant decides to fight the citation.
- All information provided to Animal Services is considered Public Record.
